INVITATION FOR BID Long Term Service Agreement for DCAP's Gas Turbines

District Cooling System and Power Plant Co., Ltd. (hereinafter referred to as "DCAP" or "Owner"), a joint venture of the PTT Public Co., Ltd. (PTT), Electricity Generating Authority of Thailand (EGAT) and Metropolitan Electricity Authority (MEA) has been awarded a contract by Airport of Thailand Public Co., Ltd. (AOT) to develop the Co-Generation Plant project to supply electricity, chilled water, and steam in Suvarnabhumi Airport.

Existing Long Term Service Agreement (LTSA) of DCAP's Gas Turbines almost expire approximately in the early of 2025 when the last unit of DCAP's Gas Turbines have already completed Major Overhaul. Therefore, DCAP need to renew LTSA for seamless taking care of our gas turbines.

The purpose of this Invitation for Bid is to obtain proposals from qualified professional companies to provide the service under the requirement in the Scope of Work. The Owner now invites your company (the "Bidder") to submit its Bid for this project.

Place of Service : The North of Suvarnabhumi Airport beside Thai Airway Catering Building, Samut Prakarn Province.

Eligibility of Bidders

Only proposals from bidders as a single company or as a Joint Venture or as a Consortium of firms who satisfy the following qualifications and certify their eligibility and qualifications by submitting evidence, detailed in the following order, will be accepted:

- Shall be the Level 4 Authorized Service Provider (Certified by GE)
- Has the existing facility to service DCAP Gas Turbine LM 6000 PD
- Has Local Level 2 Workshop in Thailand
- Has Level 4 Workshop for Major Overhaul
- Shall not be named in the list of work abandoners published by the Office of the Prime Minister, and/or in the debarment list and/or the list of work abandoners declared by DCAP.
- Shall not be a Jointly interested Bidder with other Bidders

Bidders shall be submitted bid security in the form of Bank Guarantee to the Owner in the amount of THB 40,000,000.00 (Forty Million Thai Baht) with the proposal.
